Location: Latchis Theater, 50 Main Street, Brattleboro, VT. 05301

Show times: Doors open at 9:30AM and show starts at 10:00AM (live judged, means no separate pre-judging and finals. Group comparisons, individual routines and award presentations are done straight through. Expected end time is 6 PM)

Divisions: Men's Bodybuilding: Debut, Teen, Junior, Novice, Open, Masters 40+, Grand Masters 50+. Men's Physique: Open. Women's Bodybuilding: Novice, Open, Masters 40+. Ms Fit Body: Open. Figure: Debut, Novice, Open, Masters 40+. Bikini: Debut, Novice, Open, Masters 40+.

Division Details: Teen: Age 19 and Under. Junior: Under age 23. Novice: Open only to those who have not placed first in any class besides Teen within any division in the same category with any organization (unless you were the only competitor in the class). Eligibility will be verified during polygraph testing. Masters Divisions: Open only to those falling into the stipulated age range. Open: Open to anyone regardless of age and level of experience. All Open and Open Masters 40+ class winners or overall winners qualify for WNBF Pro status!

Classes: Open bodybuilding classes will be filled based upon weight. All Novice, Masters, Classic, and Grandmasters will be split based on entries and determined on the day of the show. Open - Figure, Bikini, and Ms Fit Body classes will be filled based upon **exact** height. (ex. 5'3½" do not round up or down)

Crossovers: Are allowed only within each division. For example - Women may do Bodybuilding, Ms Fit Body, Figure, and Bikini as long as they are all in the same division. (open or novice) ALL athletes meeting the age requirement may compete in Masters or Grandmasters as well.

Tickets: Adult General Admission \$40. (Children under age 10 are Free), Trainers Ticket \$60.

Drug Testing: Polygraph testing for all competitors is \$50. payable in cash to the polygraph examiner at the time of testing. Photo identification required. If any competitors are not polygraph tested for the event they are ineligible to compete. Plus all competitors subject to additional forms of testing, if requested, at the discretion and expense of the promoter.
